1. The Stallion Fee includes a non-refundable Booking Fee (\$500) which shall be payable upon execution of this contract. The remainder of the Stallion Fee is due when you Mare is checked "in Foal" or before your Mare leaves our farm. The breeding season will begin February 1st and end July 12th.

2. **BOARD & VETERINARY CHARGES:** The Breeding Manager agrees to provide suitable facilities for the care and feeding of the Mare and/or foal while in Breeding Manager's custody. The Mare Owner agrees to the rates listed in the fee schedule above. The Mare Owner agrees to pay all boarding and veterinary expenses incurred by the Mare and/or foal while under the care of the Breeding Manager.

3. Mares who are on site will receive BREEDING PRIORITY and then all shipping requests will be filled on a first come first serve basis.

4. **CONDITION:** The Mare Owner agrees that when the Mare is delivered to the Breeding Manager, the Mare will be in healthy and in sound breeding condition. Upon or before delivery of the Mare to the Farm, the Mare Owner must provide the Breeding Manager with the following records for the Mare including, vaccination schedule, deworming, farrier, EVA status and any other health and reproductive records.

5. Diligent efforts will be made to impregnate the Mare. Breeding Manager's veterinarian will examine the mare for normal breeding conditions and will administer care as necessary.

6. **Embryo Transfers:** If more than one embryo is produced from a Stallion under this agreement and if multiple embryos are transferred, then the Mare Owner must notify the Breeding Manager within 48 hours of transfer of the embryo(s). If embryo transfers results in multiple pregnancies, then the Mare Owner must pay the Breeding Manager the Stallion Service Fee for EACH pregnancy before ANY Breeder's Certificates will be issued.

6. LIVE FOAL GUARANTEE. If the mare fails to produce a live foal from the breeding privilege granted by this Agreement, the Mare Owner may re-breed the mare (or a substitute mare mutually agreed upon by the Mare Owner and the Breeding Manager) during the subsequent breeding season ONLY. THE LIVE FOAL GUARANTEE IN THIS CONTRACT IS NON-TRANSFERABLE AND NON-ASSIGNABLE.

7. TERMINATION. The parties herein agree that should the Stallion die or become unfit for any reason, then this contract shall become null and void and both parties are relieved of any further obligation. Likewise, any monies paid by the Mare Owner toward the Stallion Service Fee, with the exception of the non-refundable Booking Fee, shall be refunded to the Mare Owner. However, the Mare Owner is responsible for all expenses actually incurred. If the Mare should die, or become unfit for breeding, the Mare Owner is entitled to return privileges with a substitute Mare that is approved by the Breeding Manager. This condition does not apply to mares being bred under the authorized re-breed privileges.

8. The Mare owner waives all claims against the Breeding Manager, Ted Robinson Cow Horse Facilities, and it's employees for the sickness, injury, or death of the mare and her offspring arising from the exercise of the breeding privilege granted in this agreement. The Breeding Manager and Ted Robinson Cow Horse Facilities waives all claims against Mare Owner for any sickness, injury, disease, or death of the Stallion arising from the exercise of the breeding privilege granted in this agreement.

9. A photocopy of both sides of the Registration Papers on your Mare must accompany this contract. The Mare Owner warrants that he/she is the owner of record of the Mare. The owner recorded on the Registration Certificate will be recorded on the Stallion Breeding Report.

10. This contract is non-assignable and non-transferable. This Agreement shall be binding upon the parties hereto, upon execution hereof, and the same may not be altered or amended, except by written mutual consent of the parties hereto. I have read the foregoing and agree to the conditions.
