


 SHIPPED SEMEN CONTRACT

1. The Stallion Fee includes a non-refundable Booking Fee (\$500) which shall be payable upon execution of this contract. The remainder of the Stallion Fee and 1st Cooled Semen shipment fees are due prior to the 1st shipment of semen. The breeding season will begin February 1st and end July 12th. Mare owners that fail to request semen during the designated season will forfeit their booking fees.
2. COOLED SEMEN SHIPMENT FEES: \$250 for each shipment by Federal Express or \$350 for each shipment by Airline service. The mare owner agrees to return semen-shipping container to the Breeding Manager in a timely manner (within 5 business days). An additional fee of \$300 will be charged for the shipping container if it is not returned to the Breeding Manager.
3. A Request for shipment of cooled transported semen must be made at least 24 hours prior to shipping time from Ted Robinson Cow Horse Facility. Any CANCELLATIONS must be made by 8:00 AM PST of the SHIPPING DAY. Mare owner is responsible for all fees of breeding the mare and agrees to comply with all breed association requirements concerning the use and handling of cooled semen.
4. Mares who are on site will receive BREEDING PRIORITY and then all shipping requests will be filled on a first come first serve basis.
5. HEALTHY MARE: The Mare Owner agrees that when a cooled semen shipment is requested, the Mare will be healthy and in sound breeding condition and that all care and diligence will be used to inseminate the mare.
6. Embryo Transfers: If more than one embryo is produced from a Stallion under this agreement and if multiple embryos are transferred, then the Mare Owner must notify the Breeding Manager within 48 hours of transfer of the embryo(s). If embryo transfers results in multiple pregnancies, then the Mare Owner must pay the Breeding Manager the Stallion Service Fee for EACH pregnancy before ANY Breeder's Certificates will be issued.
7. LIVE FOAL GUARANTEE. If the mare fails to produce a live foal from the breeding privilege granted by this Agreement, the Mare Owner may re- breed the mare (or a substitute mare mutually agreed upon by the Mare Owner and the Breeding Manager) during the subsequent breeding season ONLY. THE LIVE FOAL GUARANTEE IN THIS CONTRACT IS NON-TRANSFERABLE AND NON-ASSIGNABLE.

8. Mare Owner agrees to provide Breeding Manager with the results of a pregnancy examination within thirty (30) days of the insemination of the Mare. A 'Breeder's Certificate' will be issued when the Breeding Manager is notified that a 'live foal' has been produced AND the Stallion Fees and all other expenses have been paid in full.

9. TERMINATION. The parties herein agree that should the Stallion die or become unfit for any reason, then this contract shall become null and void and both parties are relieved of any further obligation. Likewise, any monies paid by the Mare Owner toward the Stallion Service Fee, with the exception of the non-refundable Booking Fee, shall be refunded to the Mare Owner. However, the Mare Owner is responsible for all expenses actually incurred. If the Mare should die, or become unfit for breeding, the Mare Owner is entitled to return privileges with a substitute Mare that is approved by the Breeding Manager.

10. A photocopy of both sides of the Registration Papers on your Mare must accompany this contract. The Mare Owner warrants that he/she is the owner of record of the Mare. The owner recorded on the Registration Certificate will be recorded on the Stallion Breeding Report.

11. This Agreement shall be binding upon the parties hereto, upon execution hereof, and the same may not be altered or amended except by written mutual consent of the parties hereto. I have read the foregoing and agree to the conditions.
